### What will my contribution fund?

## How will this benefit my organisation?

Australia has some 2000 registered co-operatives, mutuals and credit unions. The Top 100 Australian co-ops, mutuals and credit unions turned over more than \$14.7b in 2011.

Around 7.5 million Australians are the member-shareholders of co-operatives, credit unions and health mutuals – about the same as the number of Australians trading private shares on the ASX.

Improving the level of public awareness of co-operatives in 2012 will:

- Encourage more people to trade with or join co-operative businesses.
- Help our businesses make their case to government on issues of importance to our various sectors (legislation, funding, markets and competition).
- Invite the mainstream media to be more interested in what we have to say.
- Help us to connect with our sector, educate our staff, our members and other stakeholders.
- Publicise our achievements and celebrate our history.



### 2012 Budget
